

ADDENDUM NO. 1

**TO THAT CERTAIN DETAILED REQUEST FOR QUOTES FOR FENCING
INSTALLATION AND REPAIR SERVICES RELEASED ON JUNE 20th , 2024**

Addendum Date: July 1st, 2024

The following changes, additions, clarifications and/or amendments are made to the Request for Quotes as of the Addendum Date. All capitalized terms not defined herein shall have the meanings ascribed to them in the Request for Proposals.

Note: In the event of a conflict between previously released information and the information contained herein, the latter shall control.

THE REQUEST FOR QUOTES IS AMENDED AS FOLLOWS:

1. The property address provided in *Section III Scope of Services: Fence Repairs w/ Additional Fencing: D*,

2. During site visits conducted on June 25th and June 26th, measurements were taken for the minimum linear feet and gate specifications for each parcel. The following “Tour Measurements and additional specifications” shall be added to “*Contractor Responsibilities: Fence And Design Specifications*” and shall be incorporated in each Respondent’s written quote. If the Respondent’s independent measurements differ from below due to the Respondent’s recommended fencing solution to accomplish the Scope of Services described, Respondent’s must identify the total linear feet per parcel for their solution:
